OMAHA METRO AREA COALITION MEETING MINUTES November 13, 2024

- I. Call to Order: Chris Wagner called the meeting to order at 9:00 a.m.
- II. <u>Welcome and Introductions:</u> Coalition members and speakers in attendance: Sharona Ernst, Palistene Gray-Moore, Jordan Cedillo, Neil Culver, Teri Speck, Heike Langdon, Derek Schwartz, Kirby Williams, Trilety Wade, Jason Sharp, and Natalie Gordon-Nash. Coalition members in attendance via Zoom: Elizabeth Woods, Jona Beck, Brian Ortner, Tom Safranek, Julie Chytil, Maggie Ballard, Lanette Richards, Jeanne Bietz, Abigail Anderson, Michaela Perry, and Whitney Abbott. Staff members: Chris Wagner, Beatha Kliewer, and Liene Topko.
- III. <u>Approval of Minutes:</u> The minutes from the October 9th meeting were included in the coalition meeting packet. No additions or corrections were made.
- IV. Alcohol's Impact on the Nebraska Tribes Addressing Violence Coalition's Work: Kirby Williams, executive director of the Nebraska Tribes Addressing Violence Coalition, shared that the mission of their coalition is to support and strengthen the prevention of and response to domestic violence, sexual assault, stalking, elder abuse, dating violence, and human trafficking against Native Americans in Nebraska through education, trainings, support, public awareness, and technical assistance. She shared that Nebraska follows national trends regarding high rates of violence perpetrated against Native people and that the prevention of alcohol misuse is a key factor in reducing violence. Kirby also shared national and local resources available to Native people of different tribes and individuals working with Native people.

V. Focus Area Updates

- a. Local
 - i. Chris Wagner shared with the coalition that board member, longtime highway safety administrator, and advocate Fred Zwonechek recently passed away. His celebration of life will be in Lincoln on November 15th.
 - ii. Wagner invited the group to participate in the Retail Alcohol Data Collaborative which is a national effort to better understand the alcohol retail outlet environment. The goal is to visit and assess 50-100 businesses in Douglas County. The Youth Leadership Network students will be taking part in this, and coalition members are invited to join the efforts.
 - iii. Liene Topko summarized the hearing for Havana Garage's sale to minor violation where the business sold to the minors a second time within less than six months. Despite the Liquor Control Commissioners finding the business guilty, they halved the penalty due to the business taking steps to prevent future violations and counsel arguing possession of alcohol on their behalf. Details of the case can be found in the November newsletter.

b. Policy

- i. Wagner informed that group that the alcohol pricing and taxation interim study has been indefinitely postponed.
- ii. Topko highlighted the Nebraska Liquor Control Commission's (LCC) legislative letter's which is sent to the Nebraska Legislature with their "wish list" for the upcoming session. The letter asked for mandatory server training of all employees; updates to how alcohol that is shipped into Nebraska is tracked; a request for a delivery license; and a request to increase liquor investigators from 6 to 9, with two going to Troop A (Omaha metro) and one to Troop H (Lincoln). c. Youth

- i. The Youth Leadership Network students will be meeting with senators and their staff to discuss evidence-based policies for preventing alcoholrelated harms, including increasing the price of alcohol. Coalition members were encouraged to join and show support for the youth during these meetings.
