### **Trump Administration Eliminates CDC's Alcohol Program**

Increases in alcohol-related deaths and harms expected



The Trump administration's reduction in force across federal agencies was felt at the small but mighty Centers for Disease Control and Prevention's (CDC) Alcohol Program, which receives a small appropriation of \$6 million from Congress to support alcohol harm reduction efforts. The Program has supported surveillance of one of our nation's most abused drugs, reviewed research findings, informed the American public about how alcohol impacts them and their communities, and provided guidance for state and local governments about evidence-based strategies that have been successful in preventing

excessive alcohol consumption in other countries and states.

Public health experts emphasize that alcohol remains a leading cause of <u>over 178,000</u> <u>deaths annually</u> in the United States, all of which are preventable. Nebraska has an estimated 1,001 deaths every year due to excessive drinking. Our state also experiences a wide range of health issues including heart disease and stroke, liver disease, and seven

types of cancer. Reducing funding for prevention and intervention programs will reverse what progress has been made in addressing this public health issue and exacerbate that alcohol-related harms communities are experiencing.

The \$6 million cut is expected to reduce capacity for data collection, eliminate research, and reduce the public's understanding of how alcohol impacts our lives and communities while simultaneously making it more challenging to build support for proven strategies for preventing alcohol-related harms. The cuts have been described as 'fiscal conservativism' and 'eliminating government overreach,' however our nation continues to shoulder enormous economic costs from excessive alcohol consumption that lead us to spend more taxpayer dollars on corrections, law enforcement, health care, etc. 2010 data shows that excessive alcohol consumption cost Nebraskans \$1.16 billion, with \$491 million paid for by the government. Eliminating this program will come back to haunt taxpayers and increase alcohol-related deaths that could've been prevented had our leaders not been so shortsighted.

The **2025 Youth Leadership Retreat** will take place on **June 3-5 at Haven 150** in Omaha. #### Register is Open: 2025 Law Enforcement Training



All Nebraska law enforcement agencies are invited to participate in the FREE 2025 Law Enforcement Training focused on alcohol enforcement. The training is scheduled for August 4-5 at the Kearney Police Department and August 6-7 at the Omaha Police Department's Training Academy. Topics covered at the training will include: creating awareness of enforcement efforts; report writing; sales to minors investigations; sales to visibly intoxicated patrons; source investigations; license inspections; and nuisance establishments. This year's trainers include Carrie Christofes (National Liquor Law

Enforcement Association), Todd Merlina (Pennsylvania Liquor Control Board Nuisance Bar Program), Israel Morrow (North Carolina Department of Public Safety Alcohol Law Enforcement), and representatives from the National Alcohol Beverage Control Association. **Training space is limited to the first 20 registrants per training site**, so act quickly to secure your spot! #### Nebraska Results of National Alcohol Product Study Revealed

Project Extra Mile was selected to participate in the Counter Tools Retail Alcohol Data (RAD) Collaborative, a national research project to help better understand alcohol availability, pricing, and



marketing of products that are especially dangerous and/or appeal to young people. During the months of January and February, staff, coalition members, and youth surveyed off-sale liquor licensed businesses in Douglas County to examine alcohol advertising, what products are available and how much they cost at various establishments.

Researchers from the University of North Texas Health Science Center (UNTHSC) cleaned up and validated the data and recently shared the coalition's results. Coalition members were able to successfully survey 92 businesses and found the following results:

### TTB Comment Period on Alcohol Labeling Extended Public input requested



In <u>January 2025</u>, the Alcohol and Tobacco Tax and Trade Bureau (TTB) opened their public comment period for mandatory <u>food allergen</u> and <u>alcohol facts</u> labeling of alcoholic products. As of mid-April, the comments period has been extended to **August 15**, **2025 at 11:59 pm EST**.

The TTB is proposing to require alcohol facts labeling including the following

on all alcoholic beverages:

- · Serving size of the product
- Number of servings per container
- Alcohol content as a percentage of alcohol by volume
- Number of fluid ounces of pure ethyl alcohol per serving
- Number of calories per serving
- Number, in grams per serving, of carbohydrates, fat, and protein

Having the above information will aid consumers make better decisions on products they are consuming and reduce excessive drinking. Comments do not need to be long; simply share why you think this would assist consumers make the best decisions for their health.

#### **Legislative Update**

Senator Juarez's <u>LB 330</u> remains stuck in the Revenue Committee. A compromise has been discussed which would decrease the 10% alcohol sales tax increase to 8% with the additional revenue being split as follows: 50% General Fund, 35% Education Future Fund to fund new social work positions in public schools, 10% Excessive Alcohol Consumption & Treatment Fund to help prevent and treat excessive alcohol consumption, and 5% Nebraska State Patrol Liquor Control Enforcement Fund to enhance the enforcement of our state's liquor laws.

LB 113 was approved by the governor and signed into law on April 14th. The bill will go into effect in September of this year. This legislative change further erodes the three-tier alcohol regulatory system by allowing alcohol retailers to have up to eight physical locations and micro distilleries to self-distribute up to 3,500 gallons of their product annually. LB 186 was also amended into this bill which allows an entertainment district to have an active street or highway running through it, with patrons being able to cross the roadway with open containers at designated locations. This provision endangers pedestrian and driver safety in these districts.
